# Change a life

Did you know there are 20,000 young people in Cambridge and District?

Local churches currently reach about 600.

Would you like to see that number grow?  
So would we.

At Cambridge & District Youth for Christ (YFC) we regularly meet young people who are asking big questions about life. Many of them have no idea that God exists, let alone that they can know his love personally. You can help to change that.



Would you be willing to give the price of a coffee every week, to help us take the good news relevantly to every young person in Cambridge & District? We are looking for 170 people to give £2.50 per week (£10 a month) or more towards this work. Would you be one of them?

For £2.50 a week you could:

- Help supply essential resources and training to volunteers running a youth club in their local community.
- Pay for 1000 invitations for our youth café outreach programme.
- Contribute towards the cost of The Hub, our residential mission training for young people aged 13-18.
- Pay for one young person to attend Fort Rocky, our weekend for young people aged 11-14.

## Who we are

Cambridge and District Youth For Christ was launched in 2001 to help local churches reach young people. We are an independent local charity funded by local individuals and churches. We focus on initiatives which help communicate the Christian message to young people aged 11-18.

## What we do

Every year, YFC leads a programme of creative outreach events called Hope Revolution, which



includes weekends away, youth café outreach, concerts and more. Through these events, young people hear the good news about Jesus expressed in powerful and relevant ways.



YFC invites local churches to become Catalyst Partners, creating new outreach

projects in their local community. We receive regular requests from Christians needing help to reach young people on their doorstep, and respond to as many as we can.

We also co-ordinate the Cambridge Youthwork



Collective, offering a range of training events for youthworkers and volunteers to inspire and equip them in their vital ministry.

## Why now?

We have recently appointed two new youthworkers, so that we can see more young lives changed. To sustain this dedicated and talented team, we need your support.

## Becoming a Shareholder

If you are a UK tax payer, then YFC can benefit by claiming Tax back under the Gift Aid scheme: for every £1 you give, we can claim an additional 25p from the Inland Revenue.
